Susan Friend stated that SEASPAR newspaper coverage has expanded greatly thanks to Morgan's efforts.

Susan reported that staff from NSSRA took a tour of the SEASPAR offices and are considering building a new office facility.

Susan thanked the Westmont Park District for inviting the Glee Club to sing the National Anthem at their "Race to the Flag" event on Memorial Day weekend.

Susan reported that the Justice Department filed an appeal on the Diastat case on day 59 of the 60 day deadline. She will inform the Board when further information is available.

Susan stated that Ron Gunter will be recognized at the Believe & Achieve Banquet for his 23 years representing the Westmont Park District on the SEASPAR Board.

Susan reported that the Downers Grove Park District, with the help of Erik Brown, has streamlined their billing for telephones, heat, and building expenses to one consolidated bill each year. SEASPAR costs over the past two years have been an average of \$3,500 to \$4,000. This will greatly reduce the time spent by the park district to calculate each individual charge every

month and improves SEASPAR'S ability to budget for these items. The costs will be reevaluated in two years.

Susan stated that June 21 is the annual meeting with election of officers. Dan Garvy and Mike Toohey from Lisle and Mike Adams from Woodridge will be unavailable to attend.

Susan updated the Board on the recent cyber attack. The Downers Grove Police Department are pursuing the identity of several IP addresses linked to the attack.

Board members recommended some additional security measures they follow that could be put in place.
