#### **Public Comment and Correspondence:**

Jamie Wilkey, from Lauterbach & Amen, provided highlights of the Independent Auditor's Report which they conducted on SEASPAR's financial operations. Ms. Wilkey commended the SEASPAR staff for their diligent work during the year, and stated that overall, SEASPAR received a clean opinion from the auditors.

Ray Jasica requested SEASPAR's assessed rate be included in the 10-year summary of the member entities Assessed Valuations and Tax Rates section. Ms. Wilkey said this information will be included along the bottom of the spreadsheet in future reports.

Cathy Morava introduced Shannon Tovey, who is responsible for Teen and Adult weekly, Inclusion, and Leisure Education programs. Shannon gave a presentation on Inclusion and how SEASPAR aides have assisted park district staff this past summer. A breakdown of summer Inclusion requests was included in the Board Packets, as well as a spreadsheet that shows the cost to each district for the last ten years.

For next summer, Shannon is going to contact the park district recreation staff in January to arrange a meeting to discuss how the Inclusion process works, ADA requirements, and ways to improve procedures so that 2014 runs even smoother than 2013. These meetings will be conducted in March. Shannon asked the Board to let her know if any new recreation staff are hired in their districts.

There was a brief discussion about the rising cost for providing aides at programs, especially during the last three years. Susan Friend noted that other SRAs have been seeing these numbers for the past five years.

Matt Corso informed the Board that SEASPAR golfer Jeff Osowski has been selected to represent Illinois next summer at the Special Olympics 2014 USA Games in Princeton, New Jersey.

Susan Friend noted that Matt Corso has been selected as a bowling team coach for the SO 2014 USA Games.

### **Fund Development Report:**

Lisa Rasin said Trivia Night was a great success. She is meeting with the Silver Lining Foundation on October 16 to discuss finances for this event, and start planning for next year. Lisa reported there was a ribbon cutting ceremony this morning at the EAGLES site in Darien for the new computer lab that was established with a donation from the Perma-Seal corporation.

## **Executive Director's Report:**

Susan Friend had samples of the paint, tiles, and flooring that will be used at the Lisle facility. Dan Garvy said they are waiting for the plans to come back from the architect and then the Lisle Board will probably award the contract to a vendor in November. He estimates that it is a six to eight week project so they are targeting an April completion.

The Affordable Care Act notification letter has been mailed to all SEASPAR part-time staff and only a few calls have been received as a result.

The Board received a copy of the revised Member Contribution spreadsheet in their Packet. Susan worked with Mike Adams and Jamie Wilkey in re-doing the numbers.

#### **Unfinished Business:**

Regarding the FY 14-15 Levy Request, Susan said a few changes had been made since last month for a total of about \$8,900. Highlights are in her report.
