Public Comment and Correspondence:

Dan Garvy asked the Board if they all agreed to cancel today's Executive Session. The Board concurred.

Shannon Tovey, Support Staff Manager, introduced herself and explained that she is responsible for the part-time/volunteer staff, interns, vehicles, and the Ability Awareness program. In addition, she is a Wellness Ambassador for the agency.

Using 2014-2015 statistics, Shannon informed the Board that SEASPAR had approximately 182 support staff assigned into 2,400 positions covering the 986 programs offered. There were also 256 volunteers who worked 2,558 hours which saved the agency approximately \$30,000 in staff costs. Twenty of these 256 are individuals who volunteer on a regular basis. Ability Awareness has been quite successful in getting volunteers for us. Through this program, staff demonstrates to 6th graders in local schools what it's like to be someone with a disability. After attending this session, many of the students are eager to volunteer to assist our participants in programs.

Shannon also highlighted the new support staff incentive program which has helped SEASPAR recruit 12 new part-time staff.

Dan Garvy thanked the Darien Park District for all the improvements they made to the EAGLES site at the Sportsplex.

Lisa Rasin said the America English concert at the Tivoli is her focus right now. Posters and tickets are available if anyone would like some.

Marketing Report:

Morgan Drdak had nothing to add to her report. She thanked the Board members who are promoting the concert on their websites.

Executive Director's Report:

In Susan Friend's absence, Dan Garvy asked if there was anything to report on the cyber attack on Susan's computer. Carol Kocek responded there was nothing to report at this point. There was some discussion among the Board members about the increasing frequency of these fraudulent activities.
