Former SEASPAR Board member Joe Long once again provided a safe environment for this annual trip.

New EAGLES adventures include a team-building challenge at the University of St. Francis, a Breaking Grounds in Drumming, and classes at Expressions Dance Studio and Lifetime Fitness.

Susan Friend stated that Dawn also has other SEASPAR duties including instructing CPR/First Aid and Medic First Aid.

Marketing Report:

Morgan Drdak stated that new banners had been created and posted in Lemont.

Executive Director's Report:

Susan Friend reported that Aktion Club will hold their Annual Banquet on Monday, October 24.

Susan Friend reported that she received a phone call from staff at the Village of Riverside regarding SEASPAR membership. She stated that their contribution would be approximately \$45,500 and that they have 8,000 residents. Mary Pezdek stated that prior to SEASPAR membership, Brookfield, Riverside, and Lyons co-sponsored a Friday night social club for approximately 25 individuals.

Susan stated that the Special Olympics Wall of Fame Dedication is on Sunday, October 30. Former SEASPAR National and International Athletes have been invited to attend the event to be recognized for their accomplishments.
