Public Comment and Correspondence:

Cathy Morava highlighted the EAGLES program. She stated she has known many EAGLES participants since their youth. Participants attend Monday, Wednesday, and Friday or Tuesday and Thursday. Only a few original participants attend five days. Cathy stated that Lisle and Darien were at near capacity with a few openings in Brookfield. Staff are pursuing leads for Lemont participation.

Cathy reported the EAGLES range in age from 22 to 45 and age out at 50. Cathy explained the groups are very active every day and older participants might not be able to keep up with the pace.

Cathy highlighted the annual camping trip to Joe Long's campground in Lena and visits to pumpkin farms. Brookfield EAGLES attended a live WGN radio broadcast at a local restaurant.

Cathy noted she hired some EAGLES staff years ago and spoke highly of their dedication to the participants and the program.

The EAGLES took their rescheduled summer 5K to the Park District of LaGrange where three groups walked laps and enjoyed a lunch together after receiving medals of completion.

In addition, EAGLES routinely get together with other SRAs, have yoga and exercise classes, music appreciation, and craft classes. They are active in community events.

Cathy regularly attends transition program IEPs for students aging out who are interested in EAGLES. Three Lemont residents are attending in Lemont on Tuesday and Thursday. Cathy invited over 30 families, some on the waiting list, to tour Lemont. Some were farther away from Lemont and had other transportation factors deterring participation.

Dawn Krawiec introduced Sioban Goddard, Special Olympics Program Coordinator. Sioban attended Monmouth College, completed an internship with Special Olympics, and worked for the WDSRA day program. She moved on to Heart of Illinois SRA in Peoria for three years where her duties included inclusion, day camp, support staff management, and Special Olympics.

Matt Corso recognized Dawn Krawiec for her five years of service. Dawn oversaw changes to the EAGLES program with the addition of the Lisle location and removal of the transportation option. She is an active part of the SEASPAR Park Pursuit team and a CPR trainer. Outside of the organization, Dawn is active with the TR Section of IPRA. Matt thanked Dawn for her commitment to the organization.

Karen Lesniak reported as a cost savings measure she temporarily suspended three smart phones not needed until summer. Karen complimented Lisa Rasin on a very energetic Trivia Night.

Fund Development Report:

Lisa Rasin stated Trivia Night was fun. She also reported she would be meeting with the new representative from the DuPage Medical Group Foundation who has donated over \$60,000 over the past two years.

Marketing Report:

Morgan reported the Winter-Spring brochure will be delivered on December 3.

Executive Director's Report:

Matt Corso introduced Cathy Marron. Cathy worked a number of years at NEDSRA and is working in the office as an administrative staff.

Matt Corso noted the office was very busy. Lots of planning has been underway with the upcoming maternity leave for Rachel Pavesich, some time off for Greg, Aaron's new duties, and the addition of Sioban.

Ray Jasica asked about St. Francis Xavier School participation. Matt stated they were again sponsoring the Friday morning bowling event and ability awareness days are planned.
