**Public Comment and Correspondence:** 

Presentation by Senior Recreation Coordinator Kim Huggins, CPRP

Matt Corso introduced Senior Recreation Coordinator Kim Huggins, CPRP, noting that Kim has been with SEASPAR for over twelve years.

Kim provided an overview of her program area, which includes trips, Friday night clubs, camping trips, special events, and facilities.

Kim noted that in 2022, three staff and nine participants took a trip to Nashville. The trip for 2023 will be to Los Angeles. Shorter trips in 2022 included Starved Rock and Galena, and a short trip to Springfield is planned for winter/spring 2023.

Kim noted that there will be six Friday night clubs in 2023, three in Lisle and three in Western Springs. Highlights from the fall club season included the Monster Bash Dance and Holiday Dinner Dance. There is also a Friday Night Fun Club for participants appropriate for a 1:6 staffing ratio. A Virtual Social Club was also offered through 2022.

Kim noted that a group of 14 participants went on a camping trip in 2022 to Norman B. Barr Camp. In 2023, the camping trip is planned for the ADA accessible camp Timber Pointe.

Kim noted that in 2022, 70 special events were offered, covering every weekend during the program season. Events included dances, live shows, and professional sporting events. Kim asked that if any member entities are offering events in 2023 that would be appropriate for SEASPAR, to please let her know.

Kim noted that she organizes facility space for programming and thanked the member entities for sharing their space with SEASPAR.

### Recreation Report:

Dawn Krawiec added to her report that Jasper Shorr has been hired as the new Recreation Specialist. Jasper will begin on January 23 and focus on leading programs and providing inclusion support.

# **Administrative Services Report:**

Karen Lesniak noted from her report that cleaning and improvements were completed at EAGLES sites. She added to her report that a refrigerator at the main office is being replaced, and lobby renovations are proceeding.

#### Marketing Report:

William Cazares had nothing to add to his report.

William addressed the Integrated Marketing Plan for 2023, noting that the Marketing Department fields a lot of project requests over the year, and the plan provides strategies to focus on overarching goals for the department.

Bill McAdam noted that the Integrated Marketing Plan was very well done. He noted his surprise at how much the age breakdown skews toward adults. Matt Corso noted that two-thirds of participants are adults, primarily because they are with SEASPAR throughout their entire lives.

# **Executive Director's Report:**

Matt Corso introduced and the Board welcomed Luke Gundersen, new representative for the Village of Brookfield, Luke Wyss, alternate representative for Westmont, and Dustin Kleefisch from the Village of Willowbrook.

Matt noted from his report that an article he and Molly Downing wrote about SEASPAR's multisensory rooms was included in the latest issue of the IPRA magazine. He noted that the story

focused on how SEASPAR's partnerships with its member entities were a key factor in the development of the rooms. He thanked the member entities for sharing their space with SEASPAR and noted that SEASPAR was a trailblazer for SRAs having dedicated space.

Matt added to his report that FY2022 audit fieldwork will begin February 6.

Matt added to his report that the paperwork for the Employee Retention Credit was submitted, and SEASPAR should receive between \$140,000 and \$172,000 in federal funding. Only \$120,000 was budgeted.

Matt added to his report that SEASPAR has begun working with a class from the University of St. Francis on a Needs Assessment which should be completed by the end of April.

# Approval of Personnel Manual Updates

Mike Adams inquired about Section 2.9 of the Personnel Manual regarding overnight pay. Matt Corso clarified that staff had previously agreed to a lesser rate of pay for overnight trips, but it has become increasingly difficult to find staff to work the trips. Overtime was discussed, and Matt noted that full-time staff and interns are frequently used to avoid overtime.

Mike Adams recommended the following changes to the Personnel Manual:

- Section 3.4: In the Accumulation of Sick Leave section, clarify that retirees receive a choice of service credit or a payout.
- Section 3.6: Change the reference to the employee definitions from Section 1.7 to 1.8.
- Section 3.11: Include a description of whom is eligible for the benefit. Matt noted that the policy was taken directly from PDRMA.
- Section 5.8: Change the language from not allowing any personal use of cell phones to allowing a de minimis personal use of cell phones.
