Executive Director's Report:

Matt Corso added to his report that former Board member Ray Jasica sent his salutations to the Board.

Matt added to his report that the Willowbrook Meet-and-Greet on October 16 went well, although only two of the families who RSVP'd attended. Another meeting in Willowbrook on December 13 will be specific to assisting families with registration for the winter/spring season, and more attendance is anticipated for that meeting.

Matt added to his report that he had discussed with the Executive Board the trouble he is having obtaining a new agency vehicle for the Executive Director. Discussion ensued, and the Board expressed understanding of the situation and directed Matt to confer with legal counsel and draw up any necessary paperwork to allow him to purchase a vehicle on his own up to an authorized dollar amount.

Unfinished Business:

FY2024 Budget and Levy Request

Matt Corso presented the budget and levy request for FY2024. He noted that it is time to increase the levy rate, as ten of the twelve member entities were paying more in contributions in 2010 than they are currently. He noted that the budget presented is a worst-case scenario that does not include anticipated grant funds. The proposed levy rate remains lower than most other special recreation associations. The Board complimented staff on the development of the budget. Discussion ensued about the financial impacts of many new or proposed pieces of legislation.

Louise Egofske moved to approve the FY2024 levy request rate of .0165% of 2022 EAVs and the FY2024 operating and capital projects budgets. Dan Garvy seconded the motion.
